

Terms & conditions

For all photography workshops by Stefanie Annique

Workshop events are operated by Stefanie Annique. These terms and conditions form the agreement between you and Stefanie Annique. By booking a workshop you sign into this agreement and agree to abide and be bound by these terms and conditions.

Article 1. Workshops

1.1 In order to get the most out of the workshop, you should ensure that you arrive on time and attend each session in full. If you are unable to attend you must notify me by email at hello@stefanieannique.com. Latecomers are admitted only at the discretion of the workshop leader. You are not entitled to a refund if, because of your lateness, you miss all or a portion of the workshop.

1.2 If behavior or conduct is deemed unacceptable or inappropriate, you will be asked to leave the workshop. No refund of fees will be made

1.3 Stefanie Annique is entitled to change the venue or make changes to the structure of the workshop. In the unlikely event that changes are made there will be notice made to all attendees as soon as possible.

Article 2. Fees & cancellations

2.1 You must pay a 50 % deposit for each workshop at the time you enroll. The amount of the deposit will be specified at the time you complete your enrollment. The 50% deposit confirms your spot on the workshop. If you cancel your enrollment in a workshop more than 6 weeks before the course start date, we will refund your deposit. After this the deposit is non-refundable. If you are uncertain you will be able to attend the course, please let me know in advance.

2.2 Following acceptance of your booking, you must pay the full amount of the workshop fee at least 6 weeks before the course start date. Failure to pay the remainder of the fee will result in your losing place in the workshop and you will not receive a refund of any portion of your deposit.

2.3 If fees are not paid by due date, Stefanie Annique will be entitled to reallocate your place. You shall remain liable for the remainder of the fee for the workshop if I'm not able to fill your place in the workshop.

2.4 Course transfer – If you are unable to attend the course and notify me 6 weeks prior to the course start date you may transfer your booking to a future course. Please note if the future course is a higher fee you will be charged for the additional amount and, at the time of transfer, you must increase the amount of your deposit to 50% of the cost of the future workshop. If the cost of the future workshop is lower than the cost of your original workshop, any amount you paid in excess of 50% of the cost of the substituted workshop will be applied to the balance of the fee due for the substituted workshop. Course transfer credit is only allowed to be used up to 1 year after initial deposit is made.

2.5 Paypal & Bank Fees – If you cancel your place on the workshop and there are Paypal/bank fees to process the refund of your booking transaction, you will be responsible for those fees and this amount will be removed from the total of your refund.

2.6 Stefanie Annique may cancel a workshop at any time prior to commencement. In the unlikely event that we cancel a workshop Stefanie Annique will notify you as soon as possible and any fees or deposits received from you will be refunded. Please note that Stefanie Annique will not refund travel or accommodation costs for cancelled courses.

2.7 Elements of each workshop (e.g.: venue, models, speakers etc.) may be subject to change without notice. No refunds will be given in the event of any such changes although we will endeavor to notify you, if possible, of the changes.

Article 3. Image usage & privacy

3.1 Attendees are not permitted to use images taken at the workshop for commercial purposes. Image usage is strictly portfolio use only (website and online). Social media usage is allowed but only to showcase your portfolio. Images must not be submitted to magazines, exhibitions or competitions without permission. Images must not be used to advertise photo shoots, workshops or products.

3.2 You acknowledge that we have advised you that none of the participants in the workshop have given releases allowing commercial use of any images taken at the workshop and that you may be subject to legal liability if you use any images commercially. You agree to indemnify and defend Stefanie Annique, its members officers and employees and all other participants in the workshop from any claims, losses, costs or expenses (including attorneys' fees and disbursements) arising out of or relating to any claim that you have used an image taken at the workshop in any manner that is not permitted in this Agreement.

3.3 If you are unsure about what is a permitted usage, please contact Stefanie Annique for confirmation; provided that, you shall not be relieved of any obligations under paragraph 3.2, above.

3.4 Attendees must credit 'Workshop by Stefanie Annique' when posting images on social media.

3.5 Attendees must not film or record the workshop at any time without permission.

Article 4. Liability

4.1 Stefanie Annique is not responsible for any personal injury or damage to property arising from incidents occurring at the workshop venue.

4.2 Please be aware of where you keep your belongings at the workshop and please remember to check your equipment at the end of the workshop so you do not leave anything behind. I am not responsible for loss of, or damage to, your personal property.
